We note that the scheduled area for SM6437 Cowie Line, pillbox and earthworks 945m SW of Stonehouse is shown as being partly in open ground and partly in an area of Native Mixed/Other Broadleaves. We recommend that the scheduled areas, alongside an appropriate unplanted buffer zone, be left as open ground, in line with UKFS guidance.
