# RE Proposed Acquisition of Borgie Log Cabin by North Sutherland Community Forest Trust (NSCFT)

As a local community choir, we fully support the above acquisition by NSCFT. The current log cabin facility is such a fantastic community resource and highly valued by all who use it. However, it is limited by its size as to how many people can be comfortably accommodated during events. Therefore, having the bigger cabin on board would extend the range of possibilities that could be offered.

The location of the cabins and proximity to the Gaelic Alphabet Spiral, within the woodland, led to our choir organising a very successful singing workshop for Seachdain na Gaidhlig 2025. We had a song written in Gaelic especially for the event which took place both at the cabin and at the Spiral. We would like to organise similar future events, which could involve more people so would definitely be keen on a bigger space!

The cabins are a perfect space for a range of music events and acquiring a bigger cabin could see possibilities of more workshops or community ceilidhs on a larger scale being organised. This would provide opportunities for developing new skills and for young musicians to develop their skills further as well as being a fantastic gathering spot for the local and wider community.

Members of the choir attended a recent fabulous family ceilidh at the cabin, the dancing space was a bit tight so a bigger space would definitely enhance the experience.

Ours is a remote community, having opportunities for meeting, learning and sharing skills is so important to counter isolation and loneliness and the cabins at Borgie certainly provide such opportunities. Extending the facilities can only be a positive.

In summary, The Big Sing Community Choir fully support NSCFT in this endeavour and wish them well in pursuing this.
